The Russian market has enormous economic potential for European enterprises. Alongside this potential, bureaucratic hurdles appear in the Russian Legislation. To distribute and sell products within the Customs Union producers must undergo mandatory testing and conformity assessment. GOST Certification establishes quality standards for the required certification of goods sold in the Russian market.

The introduction of Customs Union Certificates, which are valid in five countries, opens up the possibility for highly export-oriented companies to obtain a certificate for serial production. Certification is available for single project shipment or for serial production for 3 to 5 Years. Foreign exporters and domestic producers must obtain Certificates or Declarations of Conformity prior to customs clearance.
